The Academy of Dover has expended a significant amount from our local reserves to reach a crucial financial settlement with Mosaica as mandated by the State of Delaware. A total of \$350,000.00 was paid in June 2015, a total of \$150,000.00 in July 2015 as well as \$50,000 in July 2016. The projected payroll accural for the summer of 2016 was \$284,304.42 and the accounts payable amounted to \$24,626.31.
